Assessment

- 1. **Nausea and vomiting:** Ask, "Do you feel sick to your stomach? Have you vomited?". Observe.
 - □ **0** = no nausea and no vomiting

 - \Box 2 = mild itching, pins and needles, burning or numbress
 - **3** = moderate itching, pins and needles, burning or numbness
 - □ **4** = moderately severe hallucinations

- □ **7** = continuous hallucinations
- 3. **Tremor:** With arms extended and fingers spread apart, observe.
 - 0 = no tremor
 - □ **1** = not visible, but can be felt fingertip to fingertip

 - □ **4** = moderate, with patient's arms extended
 - □ 5 =
 - 6 =
 - \Box 7 = severe, even with arms not extended
- 4. **Auditory disturbances:** Ask "Are you more aware of sounds around you? Are they harsh? Do they frighten you? Are you hearing anything that is disturbing to you? Are you hearing things you know are not there?" Observe.

 - □ **1** = very mild harshness or ability to frighten
 - \Box **2** = mild harshness or ability to frighten
 - □ **3** = moderate harshness or ability to frighten
 - □ **4** = moderately severe hallucinations
 - □ **5** = severe hallucinations
 - □ **6** = extremely severe hallucinations
 - \square **7** = continuous hallucinations

5. Paroxysmal sweats: Observe.

 - \Box **2** = mild sensitivity

- 7. Anxiety: Ask "Do you feel nervous?" Observe.
 - □ **0** = no anxiety, at ease

- Headache, fullness in head: Ask "Does your head feel different? Does it feel like there is a band around your head?" Do not rate for dizziness or lightheadedness. Otherwise, rate severity

9. Agitation: Observe.

- 10. Orientation and clouding of sensorium: Ask "What day is this? Where are you? Who am I?"

 - □ **2** = disoriented for date by no more than 2 calendar days
 - \Box 3 = disoriented for date by more than 2 calendar days
 - □ 4 = disoriented for place/or person
