The following Home Safety Checklist has been developed as a tool for foster care support agencies and family based carers to use as a guide when conducting assessments, to assess and resolve home safety issues.

Questions 1 - 42 must be completed with all family based carers. Subsequent questions, related to infant/young child, vehicle, pet, pool/spa, and farm/rural safety, are to be completed if applicable to the family based carers' property and/or approval conditions.

PLEASE NOTE: For any questions marked with a 'NO' response, a comment outlining a description of the safety issue must be included, and a corresponding action/risk management plan reflected in the 'Summary of identified safety issues and actions to be completed' section below.
