The Parents desire to establish a parenting plan that promotes the best interests and well-being of the Children while minimizing direct communication and interactions between the Parents;

## Sections include:

### 1. Custody

### 2. Decision-Making

**B. Communication During Exchanges:** The Parents shall limit communication during child custody exchanges to essential information regarding the Children's well-being.

## 9. Entire Agreement

This Plan constitutes the entire agreement between the Parents with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

## 10. Governing Law
